 - Submit your Outstanding Music Teacher Nominations
 - Elementary K-6
 - Middle Level 6-8
 - High School 9-12
 - Must be currently teaching in that level
 - Must have taught for at least 8 years
 - Program must have shown growth or consistency
 - Will be recognized at the mini convention for each level
 - One will be chosen by the executive committee to represent North Central District at the State level for Teacher of the Year
 - Due September 1
 - Outstanding Administrator Award nominations are due October 1
 - ISW clinic proposal, Hall of Fame nominations cue October 1
 - Exhibits for this year's ISW will be in the Expo Hall of Century II.
 - ALL State Ensemble participation fees and ISW registration will be \$5.00 more due to the added cost of renting the Expo Hall.
 - There will be a "teachers' lounge" area in the Expo Hall as well as the concessions stand, to allow for participants to socialize in a central area of the convention.
 - The All State Elementary Choir will become an annual ensemble
 - Northeast District is ready to split. All the officers are in place.
 - The split will occur on March 1st, 2018.

 - Auditions at Junction City High School Nov. 5
 - Recorded auditions will be available for students with conflicts as outlined in the District Handbook.
 - o Will email the cuts
 - State description should match the state sight

 - The Clinician this year will be Julie Yu-Oppenheim from Kansas State
 - Will perform the three required pieces for State this year and a fourth piece Capan Lango? with percussion
 - o Performance tracks are on the web site, easy for your students to use
 - o Email Kevin Johnson for students to be separated into S1 S2 rooms, etc. closer to time
 - Register one time only.
 - Need to communicate with band colleagues if a student is auditioning for both band and choir.
 - There will be a checkbox on the form, so that we know who is auditioning for both band and choir.

- High School Orchestra Chair David Bernard-Stevens
 - Clinician will be Dave Klien, retired from Kearney, Nebraska
 - Former National Teacher of the Year Candidate.
 - o Violins and Violas both scales and the Mendellsohn
 - Celli both scales and the Mozart
 - Bassi (not the jazz guy) both scales and the Mozart
 - They will use the same Live Audition procedure as last year with 2 judges per room with 3 rooms

• Middle School Band Chair – Sean Keasling

- Bill Clausing from St. John will be the clinician.
- Recorded auditions from the Rubank Intermediate for winds, Audition Etudes and Basic Drumming books for percussion
 - We will be using the cycle 1 material this year.
 - The requirements are listed on the website

- He does have the audition music on PDF if directors need them
- We will be using the "Festival Scores" system developed by Troy Johnson for the recorded audition procedure this year.
 - Troy Johnson reported that is an online audition management system.
 - o It is flexible in what instruments/voices are auditioned.
 - o It is flexible with the number of judges that are used
 - You can upload any rubric you would like the judges to use to the system.
 - o dates for the audition upload **Oct. 1-Nov. 7** at 11:59 PM
 - o Judging will begin Nov. 9-Nov. 25
 - o Roster will be posted Nov. 28
 - o It is all done digitally.
 - No late entries are allowed.
 - The chair person can monitor the progress of each judge.
 - Judges can listen to the auditions anywhere
 - Troy suggested that judges use high quality headphones.
 - Judges can flag an entry if it sounds like improper audition procedures have been used.
 - When judging is complete, ever entry is ranked based on the average score from each judge.
 - Rosters are published to the "Festival Scores" website and can be exported out. Into a document.
 - Price is \$1 dollar per completed entry.
 - The full audition must be completed before we are charged.
 - If three audio files are required (chromatic scale, major scale, auditions material) they all must be uploaded to be judged.
 - For tie breaks, the rubrics are weighted. The top category is the deciding factor in a tie.
 - Music will be available for directors to pick up at the December mini convention

 - o Deadline is Nov. 20

 - o February 4 is the performance date with a contingency of Feb. 11 at Junction City MS

- o All State Ensemble Eligibility
 - The director who registers students for these ensembles MUST be a member of NAfME.
 - This will be stated in the All State Manager as directors register their students.
 - The All State Manager will be connected to the KMEA member website www. members.ksmea.org (link on the agenda)
 - Membership must be CURRENT, check to see if yours expires right before ISW
 - If there are multiple directors at a school, the director who is authorized to register students must be a member of NAfME.
 - Check that Kansas is selected as the primary state
 - This is policy at the District level as well.
 - Use your same login information as the members site
 - If a student auditions for both band and choir, BAND DIRECTORS must check the box for dual audition
 - Mark the preferences, choir will not show up if that previous box was not checked
 - Instrumental and Choir chairs will receive both entry queries
